

This is the inaugural timetable for tourist class services between Johannesburg and London.

From 1954, South African Airways issued timetables for intercontinental routes (i.e. Johannesburg-London) showing both tourist and first class services. Complete system timetables (also including domestic and regional international routes) appeared in 1956.

PASSENGER INFORMATION

* * *

RESERVATIONS:

To ensure your passage on the required date, a reservation should be made and fare or deposit paid well in advance. At destination or transfer point you are advised to confirm return or onward reservations.

CANCELLATION:

If you have to cancel or defer your reservation, please let us know at the earliest possible moment and return your ticket. We cannot guarantee refund of fare for reservations cancelled or transferred at short notice.

DEPARTURE FORMALITIES:

It is essential that you attend at the departure Terminal or Airport not later than the time advised as this allows the minimum time to complete all embarkation formalities. Flights cannot be delayed to accommodate passengers arriving late, and we cannot accept any responsibility in such cases.

PASSPORTS, PERMITS AND VISAS:

Any Travel Agent or S.A.A. office will gladly help you obtain all necessary travel documents — passports, endorsements, visas or permits. Some Consulates, however, insist on personal attendance. When travelling remember to carry your passport. Do not pack it!

HEALTH REGULATIONS:

Valid certificates of inoculation and/or vaccination issued on special international forms are an indispensable requirement of most countries. Please ask our advice concerning those necessary in your case. Certificates should be carried attached to your passport.

STOPOVERS:

You may break your journey at one or more places en route yet retain the benefit of the through fare, provided that you give us notice when you make your reservation. Hotel expenses at each such stopover will be your responsibility.

VALUABLES:

Valuable articles, such as jewellery, should be carried personally whenever possible. Please remember that the transfer of valuables is governed by currency regulations — you should ask your Travel Agent or S.A.A. for advice on this point.

BAGGAGE ALLOWANCE:

The free allowance of baggage is 20 kilos (44 lbs.). Children at half-fare get the adult allowance. Infants travelling on the 10% basis have no free allowance, but a carrycot or portable cradle is allowed as part of the child's personal weight. Personal articles — such as a lady's handbag, spare overcoat, binoculars, etc. — will be carried free. Brief cases, attaché cases, and parcels are NOT included in this category and will be weighed as part of your free allowance.

REDUCTION FOR CHILDREN AND INFANTS:

One child under 2 years of age accompanied by an adult passenger and not occupying a separate seat will be carried at 10% of the adult fare. (No free baggage allowance). Additional children under 2 years of age and all children under 2 years occupying separate seats as well as those between 2 and 12 years of age pay 50% of the adult fare. (Normal free baggage allowance).

PROHIBITED ARTICLES:

Government regulations do not permit the carriage of inflammable or explosive material in aircraft. You are therefore reminded not to carry in your baggage or on your person any articles which are easily ignited, such as cigarette lighter fluid, matches, photographic flash bulbs, etc. The only exception is that where smoking is allowed on aircraft, you may carry a small supply of safety matches or a lighter on your person.

YOUR TICKET AND CONDITIONS OF CONTRACT:

Your ticket is issued subject to these Regulations and to our General Conditions of Carriage of Passengers and Baggage, of which you will find an extract in the ticket.

PUNCTUALITY:

Although we do everything in our power to ensure the punctuality of our services, S.A.A. cannot accept responsibility for any delay or suspension of a service, nor can we guarantee that connections will be made with other air services or with surface carriers.

MEALS:

Meals are served either on board the aircraft or at stopping places en route.

INLIGTING VIR PASSASIEERS

BESPREKINGS:

Bespreek vroegtydig en betaal die reisegeld of deposito om te verseker dat u op die vasgestelde datum sal kan reis. Dit is raadsaam om op u bestemming of oorspreekplek te bevestig dat u reise of reis verder aan bespreek is.

KANSELLEER VAN BESPREKINGS:

Indien u u plekbespreking moet kanselleer of uitstel, sorg dat ons onverwyd in kennis gestel word en stuur u kaartjie terug. Ons kan nie waarborg dat die hele bedrag terugbetaal sal word as u met kort kennisgewing besluit om u reis te kanselleer of uit te stel nie.

VERTREKFORMALITEIT:

U moet u nie later as die vasgestelde tyd by die eindpunt of lughawe aanmeld nie, aangesien dit die minimum tyd toelaat vir die voltrekking van al die reïformaliteite. Vlugte kan nie vertrap word vir passasiers wat hulle laat aanmeld nie en ons kan geen aanspreeklikheid in sulke gevalle aanvaar nie.

PASPOORTE, PERMITTE EN VISUMS:

Ons plekbesprekingskantoor of u reisagent sal u met graagte help om die nodige reisdokumente te verkry soos paspoorte, endossemente, visums en permitte. Sekere konsulate dring egter daarop aan dat u dit persoonlik moet gaan haal. Maak seker dat u u paspoort by u hou gedurende die reis — moenie dit in u reistas pak nie.

GESONDHEIDSREGULASIES:

Geldige sertifikate van inenting en/of inspuiting, uitgereik op spesiale internasionale vorms, word deur die meeste lande vereis. Vra ons asseblief water sertifikate in u geval nodig sal wees. Sertifikate moet aan u paspoort vasgesteek word.

ONDERBREKING VAN REISE:

U kan u reis op een of meer plekke onderweg onderbreek sonder om die voordeel van die deurreisgeld te verloor, mits u ons daarvan verwittig wanneer u u plek bespreek. U moet egter self u hotelkoste op sulke plekke betaal.

WAARDEVOLLE ARTIKELS:

Waar moontlik, moet u waardevolle artikels soos juwele by u hou. Onthou asseblief dat valutaregulasies van toepassing is op waardevolle artikels wat uit die land geneem word — vra ons of u reisagent dus om u van raad te dien in hierdie verband.

VRYBAGASIE:

Twintig kilo's (44 pond) vrybagasie word toegestaan. Kinders wat teen halfrys reis, is ook geregtig op hierdie gewig. Geen vrybagasie word toegestaan vir babas wat teen 10 persent reis nie, maar 'n draagbare kindermantjie of wieg word toegelaat as deel van die baba se persoonlike gewig. Persoonlike artikels soos 'n dame se handsak, jas, verkyker, ens., sal vry vervoer word. 'n Aktetas, dokumentekoffertjie en pakkies word nie hierby ingesluit nie, en sal geveeg word as deel van u vrygewigbagasie.

AFLAG VIR KINDERS EN BABAS:

Een kind onder 2 jaar wat met 'n volwassene saamreis en nie van 'n aparte sitplek gebruik maak nie, word teen 10 persent van die reisegeld vir volwassenes vervoer. (Geen vrybagasie word toegestaan nie). Addisionele kinders onder 2 jaar en kinders onder 2 jaar wat aparte sitplekke gebruik, asook kinders wat 2 jaar oud is maar nog nie 12 jaar nie, moet 50 persent van die reisegeld vir volwassenes betaal. (Vrybagasie soos vir volwassenes word toegestaan).

VERBODE ARTIKELS:

Die vervoer van ontvlambare of ontplofbare goedere op vliegtuie word by goewermentsregulasies verbied. U word dus daaraan herinner om nie ontvlambare artikels soos brandstof vir sigaretaanstekers, vuurhoutjies, fotografiese gloeilampies, ens., in u bagasie of aan u persoon te hou nie. U mag 'n klein hoeveelheid veiligheidsvuurhoutjies of 'n sigaretaansteker by u hê slegs as u met 'n vliegtuig reis waarin u toegelaat word om te rook.

U KAARTJIE EN DIE KONTRAKVOORWAARDES:

U kaartjie is uitgereik onderworpe aan hierdie regulasies en ons Algemene Voorwaardes vir die vervoer van Passasiers en Bagasie, waarvan 'n uitreksel op die kaartjie verskyn.

STIPTHEID:

Ofskoon ons alles in ons vermoë doen om die stiptheid van ons diens te verseker, kan die Suid-Afrikaanse Lugdiens geen aanspreeklikheid aanvaar vir vertraging of intrekking van ons diens nie en kan ons ook nie aansluiting met ander lug- of oppervlakvervoerdienste waarborg nie.
